

AUCTION TERMS FOR LIVE AUCTIONS

§ 1.

1.1. Sales may be sold under the rules for used items. Its total price is the auction price plus a premium of 25% auction fee and VAT - minimum kr. 100.00 incl. VAT. This amount is paid in cash, MobilPay or Visa card. **NB: Eurocards and MasterCard will not be accepted** The buyer can not deduct input VAT.

1.2. If the item is sold added tax, the total price will be the price when knocked down plus VAT, plus a premium of 25% auction fee incl. VAT – however, minimum DKK 100,00.

§ 2.

2.1. In no case will purchased property be handed over to the buyer, until the purchase price has been paid.

§ 3.

3.1. The items sold are received by the highest bidder in the condition in which they are found when knocked down, and be available as from this time at the buyer's expense and risk in every respect. The purchased must be collected and paid in cash immediately after the auction. As there has been inspection, complaints will be dismissed. For proper names, catalog text, age particulars, dimensions, weight, carats etc. is not guaranteed. Sales bears no responsibility for the Requester, the auctioneer and / or Hillerød Auctions, why there is no guarantee for the buyer.

3.2. Hillerød Auctions is covered by the Danish auction law.

§ 4.

4.1. Dispute upon the highest bid will be decided by a new call. Minimum bid and overbids may be determined by the auctioneer, who also decides if there are any dispute about the tender.

§ 5.

Whoever buys to another individual, will be responsible as guarantor. If two or more buys together, they are jointly responsible. Those who vouch for others, will be liable as jointly surety.

§ 6.

6.1. If more items are purchased, they will all be registered on the same bill, considered purchased as a single purchase.

§ 7.

The Danish Parliament adopted with effect from 1 July 1990 a law on a resale royalty of 5% to artists in Denmark and several other countries. The tax is levied on the sale of works of art by living artists or artists who have died for less than 70 years ago. The royalty shall be payable only where the hammer price plus the fee exceeds kr. 2.000,00. For the effects thus subject to due legal provision, the payment will be put upon the buyer. The affected effects will in the catalog be marked with ⌘.

§ 8.

8.1.Buyers are fully responsible for the effects bought, fulfills all legal requirements before they are used. The buyer also has the full responsibility to obtain permission to use various software / patents etc. of their respective holders.

§ 9.

9.1.If you can not be present on the auction day, you can submit binding absentee for the auctioneer.

§ 10.

10.1.The purchased effects must be picked up by the auction end, and not later the next working day, unless the buyer has made a special agreement with Hillerød Auctions.

§ 11

11.1Ownership of the goods sold, shall pass to the buyer when the entire purchase price incl. VAT and costs are fully paid, and including any checks are redeemed for cash.

§ 12.

12.1.If a buyer fails in his obligations, including the timely collection of the purchased goods, this will without notice be sold off again - either by private or by auction, at the buyer's expense, and he is then obligated to replace the consequent loss without having access to a possible surplus.

§ 13.

13.1.Buyers residing abroad can obtain exemption from payment of VAT at the applicable rules.

§ 14.

14.1.Right to make changes and additions to the auction terms are reserved Hillerød Auctions.
